What is the overall deductible?	Network providers: \$0 Individual/\$0 Family – Option 1 \$250 Individual/\$500 Family – Option 2 Out-of-network providers: \$500 Individual / \$1,000 Family – Option 3	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u>	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive</u> <u>services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?
